2. TERMS, CONDITIONS & CODE OF CONDUCT

- **Participation in an Adult Women's League:** I understand and explicitly accept that the player is being called up to participate in a highly competitive senior women's soccer league. I acknowledge that competing against adult athletes involves a significantly higher level of physical play, velocity, and strength. I willingly accept all associated risks, both physical and legal, inherent to playing in this advanced age division.
- **Sportsmanship & Mutual Respect:** I agree to uphold and maintain the highest ethical standards of sportsmanship at all times. I will treat all teammates, opposing players, match officials, coaches, and spectators with absolute dignity and respect. Verbal abuse, aggressive posturing, foul language, and intentionally reckless or dangerous play will not be tolerated under any circumstances.
- **Progressive Disciplinary Action:** I recognize that player conduct is strictly regulated by the league. Should the call-up player receive **two (2) or more formal warnings** (including yellow cards, referee standard write-ups, or official post-game incident reports) concerning unsportsmanlike behavior:
 1. The player will face an immediate administrative suspension from all call-up eligibilities.
 2. A mandatory disciplinary hearing with the **SJSC Executive Office** will be convened.
 3. The SJSC board retains ultimate authority to determine if the player may resume participation in the league.
